#### **Veteran's Aware Hospitals Programme Launched**

NHS Improvement released news last week about the launch of the Veteran's Aware Hospitals programme. As an initiative, it will run alongside the GP friendly practices and should really help the Armed Forces Community in terms of awareness and understanding of the challenges they face and ensuring that the NHS always consider the Armed Forces community when planning treatment.

When a Trust is accredited as a Veteran's Aware Hospital, they commit to the following three statements:

- 1. We strive to be an exemplar of the best care for veterans and their families.
- 2. We encourage all patients to let us know if they have ever served in the UK armed forces so that we can best support their care needs.
- 3. We are committed to learning from our patients and their families to improve quality of care. More information can be found **here**.

#### **Automatic Disqualification Rules for Charity Trustees and Charity Senior Positions**

On 1 August 2018, new provisions of the Charities Act 2011 came into force that bolstered the rules that govern the automatic disqualification of charity trustees resulting in a longer list of circumstances under which automatic disqualification can be triggered. A further substantial change is the extension of the automatic disqualification regime to people acting in senior manager roles within charities, as well as to trustees. 51 businesses have been honoured for their commitment to the military, including employing former service personnel, their families, and reservists. The MOD's Employer Recognition Scheme 'Gold Awards' awards were handed out to businesses and organisations who have shown outstanding support for the military community and the Armed Forces Covenant.
